I understand that my child will be participating in a hands on outdoors clinic sponsored or run by Wik's World Outdoors, LLC on the above date, which will range from shooting a bow & arrow, walking in the woods.

I am aware that outdoor instruction and participation in mock-hunting practices are hazardous activities and that my minor child is voluntarily participating in these activities with knowledge of the danger involved and I hereby agree to accept any and all risk of injury.

I understand that among other risks attendant to participating in the outdoors is the possibility of ankle injuries, knee injuries, poison ivy, poison oak or injuries to any other part of my child's body. I further understand that, despite caution on the part of any instructor, this does not reduce the risk of injuries to my child's ankle, knee, or any other part of my child's body.

I agree that I will release Wik's World Outdoors, LLC from any and all responsibility or liability for injuries or damages to the user of any equipment, including but not limited to, bows, arrows field points, equipment, household items on premises, or to any other person. I agree not to make any claim against or sue Wik's World Outdoors, LLC for injuries or damages relating to outdoor instruction, playing, and/or the use of archery equipment or facilities. I agree to release Wik's World Outdoors, LLC from any such responsibility whether it results from the use of this equipment/facilities by my child or whether it arises from any negligence or other liability arising out of the equipment, the facilities, or the supervision by Wik's World Outdoors, LLC, its agents, members, or employees of the facilities or the activities carried out on in the facilities.

I understand that I am responsible for any damage to the facilities or equipment caused by my child's intentional acts or negligence. This includes but is not limited to theft or loss.
